MINUTES OF THE PARISH COUNCIL MEETING HELD AT JUBILEE HALL, BARLEY CLOSE, BLOXHAM ON MONDAY 3 JUNE 2024 AT 7.00PM

PRESENT: Chairman, Councillor David Bunn; Councillors Joanna Barton, Amanda Baxter, Steve Craggs, Mike Fenner, Alex Harrison, Neil Hegarty, David Morris and Nick Rayner.

ALSO IN ATTENDANCE: County Councillor Kieron Mallon, District Councillors Gordon Blakeway, David Hingley & Rob Pattenden and two members of the public.

The Chairman welcomed Amanda Baxter and Nick Rayner to their first meeting of the Parish Council, since their co-option.

19/24 Apologies – Parish Councillor Russell Avens submitted his apologies because he was running a marathon.

Theresa Goss (Clerk & Responsible Financial Officer) also submitted her apologies.

Resolved that the apologies from Councillor Russell Avens be approved and the absence authorised.

- **20/24 Declarations of Interest** There were no declarations of interest.
- **21/24 Minutes** Prior to the meeting, the minutes of the meeting held on 13 May 2024 had been circulated to the Parish Council and were taken as read.

Resolved that the minutes of the meeting held on 13 May 2024 be approved.

- **22/24** Matters Arising There were no matters arising.
- 23/24 Heritage Quarries The Chairman reported that representatives from Heritage Quarries had been invited to attend the meeting to discuss the impact on Bloxham of large vehicles using the A361 through the village to visit their quarries.

However, the representatives had advised that morning that they were unable to attend and they would be invited to attend the meeting on 1 July 2024 instead.

It was also reported that HS2 vehicles continued to break the speed limits through the village and residents were advised to collate as much information as possible about the offending vehicles, to enable the information to be passed to Heritage Quarries.

Resolved that the report be noted.

24/24 Chairman's Announcements

- Parish Councillor Russell Avens, Marathon Run Councillor Avens had set off from Lands End on his epic run to John O'Groats, on 1 June 2024 and he was due to finish on 4 July 2024.
- Jubilee Hall Gigaclear was installing Wi-Fi at the Hall, however it had been delayed due to the requirement for a pole to be erected. There had not been any further incidents of young people climbing onto the roof of the Hall.
- Fun Day Councillor David Morris would collect the gazebo from the David Tyrrell Recreation Ground pavilion so it could be erected at the Fun Day. The Clerk would be able to clarify the process for returning the litter picking kits. The Chairman and Councillor David Morris and Steve Craggs would be the Parish Council's representatives at the 'Drop-In and Chat' session. **Action NH/TG**
- Oxfordshire County Council's Highways Engagement Team A meeting with the County Council's Engagement Team had been re-scheduled for 10.30am on Wednesday 12 June 2024. The Chairman would

be attending with Councilors Mike Fenner and Alex Harrison. County Councillor Kieron Mallon would be invited to attend. There were a number of possible discussion points including the Courtington Lane footpath, white & yellow lining, the Ells Lane road edging, the Queen Street pothole and the footpath by Hillcrest.

- Portable Speed Indication Device (SID) The results of the data collection from the SID located outside St Mary's Church on Church Street, showed a drop in vehicle speeds, since the implementation of the 20mph speed restrictions. The unit was currently located on Barford Road.
- Noisy Manhole Covers in High Street Thames Water had declined ownership of the manhole covers and so too had the County Council (OCC). However, OCC had been advised that that 'Highway' was cast into the covers but no response had yet been received.
- Bloxham School Founders Day/Ball This event was due to take place on 22 June 2024 and letters were being sent by Bloxham School, to any residents who might be impacted by the additional traffic and pedestrians. There would also be additional marshals to manage the parking.
- Defibrillator at the Piggery Grant funding was no longer available for a new defibrillator, therefore the unit would be funded by the Parish Council, as previously agreed.
- Travellers It had been reported that Travellers would be in the village on bank holiday Monday and it was initially thought they would reside by Brompton Farm and on then South Newington Road. Thames Valley Police were also made aware, however, the Travellers did not arrive.
- **25/24** Open Forum The residents did not wish to address the Parish Council.

(For information, following guidance from the National Association of Local Councils, the Parish Council did not specifically name individual residents within its minutes, unless they were speaking in an official capacity)

26/24 Reports from County and District Councillors – Prior to the meeting, County Councillor Kieron Mallon had circulated his report to the Parish Council.

Councillor Mallon highlighted that he and the Chairman had attended a positive meeting with the Head Teacher at the Primary School to discuss highway issues. Councillors Joanna Barton and Alex Harrison had also met with representatives from the Cherry Tree Centre to discuss their future funding.

District Councillors David Hingley and Rob Pattenden advised that they were Leader of Cherwell District Council and Portfolio Holder for Healthy Communities, respectively.

The Councillors were thanked for their reports.

27/24 Environment/Village Matters

i) 20mh Speed Restrictions – The Chairman reported that a meeting would be held with Anthony Kirkwood from the County Council's 20mph Speed Restrictions Team in early July 2024, to discuss the roll out of the project in Bloxham.

iv) Planning Application 23/01265/OUT, OS Parcel 0078 North West of Quarry Close, Quarry Close, Bloxham – The Parish Council discussed the Planning Inquiry relating to the refusal of outline planning permission by Cherwell District Council for the erection of up to 60 dwellings with public open space, landscaping, sustainable drainage system (SuDS) and vehicular access point. All matters reserved except for means of access.

Resolved that the report be noted and a meeting be arranged with the Cherwell District Council Planning Officers to discuss the Planning Inquiry and how it will be approached by both the District and Parish Councils. **Action TG**
